Discussion Items:

1. Articulation Report (Jerry Castillo) Curriculum needs to be UCTCA approved prior to being submitted for IGETC. CSUs require that courses are baccalaureate level courses (such as 100 level courses), in which they do not require prior transfer approval like UC.
2. Guided pathways sequences for new and revised degrees and certificates effective Fall 2022. In addition to the curriculum revisions, the guided pathways and course sequences also needs to be updated where appropriate. A list of degrees and certificates that were approved for Fall 2022 was shown to the committee. Sequences need to be attached in the proposals.
3. Degrees and certificates including Calculus courses need to be updated and resubmitted for approval effective Fall 2023.
