### **Discussion Items**

- 1. Brown Act Committees Committee members are obligated to attend CCI in person but are allowed to join remotely two times per year once a semester per calendar year. Technical review will still be held online.
- Articulation Report (Jerry Castillo) Jerry will continue to submit CSU GE and IGETC (his deadline is December 2023). On the top of the AO Report are Guiding Notes, UCTCA Course Transferability, C-ID, IGETC Standards, and Assembly Bills. Private institutions will now be included in ASSIST. Area F was grandfathered to IGETC 7 before, but now new courses will need to be directly submitted for IGETC 7.
- 3. AB 928 update ICAS will establish the pathway by May 31, 2023. The I<u>CAS document</u> lists the directions of Cal-GETC.
- 4. Effective terms and streamlining curriculum There will be a curriculum session for Spring Flex Day and future CIL sessions. When a degree or certificate comes through CCI, the faculty will attend an additional technical review session after the first CCI reading to ensure accuracy and completion prior to additional CCI readings for approval. Faculty will also need to have all necessary supplemental documents attached by the additional technical review attendance.
- 5. CS G178 Visual C# .net updated DE addendum effective Spring 2023 and COR effective Fall 2023 The department is cleaning up the COR in order to meet the requirement of CTE CORs being reviewed every two years and currently there are students enrolled with the online modality in the current term (Spring 2023). The course was intended to retire effective Fall 2024. The Computer Science Department will discuss whether the course plans to be scheduled last and verify retirement term.
