- 1. Articulation Report (Jerry Castillo) Jerry provided articulation documents for all departments. The GWC Active Courses documents includes all active courses that may be submitted for IGETC with notes / directions that may help courses gain IGETC approval. Jerry has CORs from other community colleges prepared for departments to review. The CSU GE document shows courses that are currently approved for articulation may be phased out in the near future. Many are in the Social Sciences Division. Departments need to make corrections and Jerry will resubmit them if they wish to maintain articulation. Jerry's UCTCA and IGETC documents lists courses that are approved and denied for UC transfer.
- 2. Credit for Prior Learning (Christy Banales). This is a new standing discussion item. Christy was absent today. Update to follow in the next CCI meeting.
- 3. AB 928 update Cal-GETC will no longer have Area E, reduced courses in Arts and Humanities, and Ethnic Studies will be included. AB 928 effective Fall 2025 and AB 1111 effective Fall 2024.
