Jennifer addressed units and contact hours are misaligned, currently totaling 5.3 units, in which the BOT will not approve due to apportionment and funding issues mandated from the State Chancellor's Office. Jen (VPI) states the result may also include not many sections available for students in order to afford the classes to run (via text message to Jennifer).

Despite union input stating there's no need to change the course, the district insists on compliance because it cannot absorb the funding shortfall. Faculty are frustrated because adjusting the course to fit new state rules would mean cutting lab hours, reducing educational quality and impacting instructor compensation.

There are options to reallocate hours between lecture and lab to maintain 108 total contact hours and meet compliance (e.g., shifting 18 hours from lecture to lab). However, compensation for lab hours is lower, leading to pay cuts and broader implications for faculty workload. Jennifer provided other hour changes to closely meet the faculty and student's needs along with being compliant with the new State funding.

The curriculum committee is willing to move forward with provisional approval while suggesting departments meet with their deans and the VPI to resolve the financial and scheduling impact. The issue remains a mix of curriculum compliance, union contract matters, and budget constraints, requiring broader institutional dialogue. There is an ongoing Senate resolution to have lecture and lab pay equal. Matt expresses appreciation to the Language Department for not changing the hours and wished there was a larger conversation amongst faculty to decide what students need.

The committee decided to review the curriculum for the Spanish Department in support of not changing the units and hours.
