- 4. Course substitution procedure (Robyn) The Transfer Center meets with students in their final semester and they need one or two classes finish. Student requests come in between August and the beginning of October. The counselor initiates a meeting with the student, the student will be contacted to approve, the Articulation Officer is contacted, then the Department Chair and Division Dean will be contacted to review the request. If the department faculty has two weeks to approve then it will be too late for students to register in August. It is suggested after one week if faculty do not respond then the request will be auto-approved.
- 5. Umoja Program This is a learning community targeted towards African-American students to support student growth, learning, and increase completion. The Umoja Program will help GWC be more inclusive. Classes that are selected for the community fit the requirements to transfer to institutions. The Academic Success Center will set up the students with academic success coaches to help students receive the tutoring they need, enrollment process, and provide embedded support. Depending on how many students are in the program, seats will be reserved the first couple of weeks of registration for them. Goal is to increase enrollment, retention, and course completion. Students are guaranteed admission to Historically Black Colleges and Universities (HBCU). Fall 2022 will be the first cohort. The proposed course sequence is heavy on Area D where students only need six units. These units will most likely be fulfilled through major prep. For example, a Business or Economics major would need to take ECON G170 and G175. The cohort courses should be reconsidered to meet major requirements in all areas instead of all in one area. Discussion will return in the fall.
