Discussion Items:

1. Articulation Report (Jerry Castillo). The ASCCC strongly urges community colleges to establish policies to allow and encourage acceptance of the courses students have taken at other colleges in a TMC-aligned degree in which GWC did adopt in 2013. Reciprocity and course substitutions needs to be reviewed again by CCI. Title 5 recommends faculty sign off on course substitutions. Jennifer is currently working with Yvonne Portillo (Transfer Center) to come up with a procedure to route the

process through counseling and discipline faculty. The course substitution procedure will be brought to CCI, Senate, and Chairs & Deans.

- 2. Communication Studies course prefix COMM to CMST: G100, G110, G112, G180, G220, G225, G255, G260, and G265 effective Fall 2022. While students are enrolling in courses, they will see Communication Studies CMST (CCC and OCC) and Communication Studies COMM (GWC). OCC has historical COMM courses so they cannot use the COMM prefix anymore, therefore, GWC will need to change course prefix COMM to CMST to eliminate barriers. All programs, prerequisites, etc. will need to be changed to CMST in the future. Sunshine moved to approve, Leilani seconded; motion approved. Course prefix COMM to CMST approved.
