III. CONTINUING & UNFINISHED BUSINESS

A. IPD Budget (includes agenda items)

- Chair Green reviewed the IPD balances. Funding was transferred from the Part-time Conference account to subsidize the General Education account which includes CARs on today's agenda.
- Rep. Walden-Hurtgen will follow up with President Randall on the status of the approval of her application for Alternative Methods.
- B. Update CCCD Accessibility Course Review (ACR)

It was incorrectly reported last semester that faculty who completed ACR were eligible for a stipend. Dean Miranda, Chair of DEAC, clarified that there are current discussions with District, but a decision is still pending. The IPD is offering (2) SAC for a max of (36) hours for completion of the ACR in Spring 2024 and retroactively for Fall 2023. A list of faculty members from Fall has been requested. The names of the next group of faculty is pending.

- Chair Green informed that after reviewing a list of faculty who participated in the Fall ACR, she determined that there is no need to issue retro SAC.
- Online Instruction states that the faculty selected for spring is unknown at this time. They indicated that names were selected from a randomized list requested by the VPI from the Office of Institutional Research of 10% Canvas courses from each modality (online, hybrid, and face-to-face).
- The IPD will continue to offer (2) SAC at this time for the ACR.

IV. NEW BUSINESS

A. Revised campus CAR approval process effective Spring 2024

In light of the recently distributed GWC Travel Instructions PowerPoint from the President's Office that included a revised CAR approval process, several faculty have inquired if the IPD CAR process has changed. The IPD Office is working with the President's Office to include instructions on the IPD CAR approval process. Additional information is forthcoming.
