Non-perishable dried goods and canned food items such as pasta, rice, cereal, dried beans, vegetables, meats, and fruits. Donations will be used to stock and supply food pantries for students on the GWC campus.

Cleaning supplies including, sponges, scrub brushes, disinfectants, all-purpose cleaners, laundry detergent, dishcloths, trash bags, and dish soap. Donations will be given to both campus and local organizations.

April
